

Criteria for partner charity applications for Quintessentially Foundation

Due to the large number of requests for support Quintessentially Foundation receives; please ensure your organisation consider the notes below regarding eligibility and the submission process before applying.

- Quintessentially Foundation supports between 3-5 charities annually
- Your charity must be registered in the UK and independently audited
- Charities must only apply if their objective falls under Quintessentially Foundation's mission; Supporting the welfare of disadvantaged communities and individuals within London
- Your charity must be independent of state, political party and religion
- Due to the large number of applications we receive each year, only charities which have been shortlisted for consideration, will be contacted
- Applications will only be considered via email - to be sent to info@quintessentiallyfoundation.org
- One document to be sent, which is no more than five (A4) pages in length, including any images to not exceed 4mb in size

Quintessentially Foundation hosts 3-5 fundraisers annually. Your application once submitted, will be put forward as a charity partner and beneficiary of such events. Information on our events calendar can be found on www.quintessentiallyfoundation.org.

If you are applying for a small grant (between £50 - £5000) please note these will be considered at the end of 2018.

The decision of the Quintessentially Foundation Trustees is final. Quintessentially Foundation reserve the right to enter into a longer partnership with a chosen charity that extends beyond the original 12-month period, should they believe it will positively benefit the reach of the work the Charity does.
